

# PRIVACY POLICY

Educate Ventures Research Ltd takes the privacy of your information very seriously. This privacy policy applies to your use of the services we make available (“Services”) and our website ([www.educateventures.com](http://www.educateventures.com)). ## Definitions and interpretation

1. In this privacy policy, the following definitions are used:

<b>Data</b>	collectively all information that you submit to Educate Ventures Research Ltd. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
<b>Cookies</b>	A small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below ( <b>Cookies</b> );
<b>Data Protection Laws</b>	Any applicable law relating to the processing of personal Data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;
<b>GDPR</b>	The General Data Protection Regulation (EU) 2016/679;
<b>Educate Ventures Research Ltd, we or us</b>	Educate Ventures Research Ltd, of Unit 6 Queens Yard, White Post Lane, London, E9 5EN;
<b>UK and EU Cookie Law</b>	The Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;
<b>User or You</b>	Any third party that accessed the Website and is not either (i) employed by Educate Ventures Research Ltd and acting in the course of their employment or (ii) engaged as a consultant otherwise providing services to Educate Ventures Research Ltd and accessing the Website in connection with the provision of such services; and
<b>Website</b>	The website that you are currently using, <a href="http://www.educateventures.com">www.educateventures.com</a> , and any sub-domains of this site unless expressly excluded by their own terms and conditions

2. In this privacy policy, unless the context requires a different interpretation:

- a. the singular includes the plural and vice versa;
- b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";

- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this privacy policy.

## Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Educate Ventures Research Ltd and Users with respect to the provision of our services or via this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Educate Ventures Research Ltd is the "data controller". This means that Educate Ventures Research Ltd determines the purposes for which, and the manner in which, your Data is processed.

## Data collected

- 5. We may collect the following Data, which includes personal Data, from you:
  - Contact information - including your name, job title, email addresses and telephone numbers
  - We may collect information you provide regarding your business as required to fulfil our contractual obligations to you

In each case, this data is collected in accordance with this privacy policy.

## How we collect Data

- 6. We collect Data in the following ways:
  - a. data that is given to us by you ;
  - b. data that is provided to us by others;
  - c. data that is collected automatically.

## Data that is given to us by you

- 7. EDUCATE Ventures Research Ltd will collect your Data in a number of ways, for example:
  - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
  - b. when you elect to receive marketing communications from us;
  - c. when you provide us with information about your business as part of the delivery of a servicein each case, in accordance with this privacy policy.

## Data that is provided to us by others

- 8. Educate Ventures Research Ltd may collect data from others in the following circumstances:
  - a. Educate Ventures Research Ltd is engaged in the delivery of the EDUCATE accelerator programme in partnership with F6S and BESA. We receive personal information about participants of the programme in order to facilitate its delivery. In each case, data is processed in accordance with this privacy policy.
  - b. In some cases we may receive data that may include personally identifiable information in order to deliver services that are chartered as part of a contract. In each case, data is processed in accordance with this privacy policy

## Data that is collected automatically

9. To the extent that you access the Website, we will collect your Data automatically, for example:
  - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
  - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

## Our use of Data

10. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience. Specifically, Data may be used by us for the following reasons:
  - a. improvement of our products / services;
  - b. transmission by email of marketing materials that may be of interest to you;
  - c. delivery of a service as required by contractin each case, in accordance with this privacy policy.
11. We may collect use your Data for the above purposes where:
  - a. we deem it necessary to do so for our legitimate interests. This is applicable when the interest is not overridden by your data protection interests (see the section headed "Your rights" below);
  - b. we need to do so in order to deliver a service as required by contract; or
  - c. you give us consent to collect your personally identifiable information for one of the above uses;
12. For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:
  - a. soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Under "soft opt-in" consent, we will take your consent as given unless you opt-out.
  - b. for other types of e-marketing, we are required to obtain your explicit consent; that is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that we'll provide.
  - c. if you are not satisfied about our approach to marketing, you have the right to withdraw consent at any time. To find out how to withdraw your consent, see the section headed "Your rights" below.

## Who we share Data with

13. We may share your Data with the following groups of people for the following reasons:
  - a. our employees, agents and/or professional advisors - To needs-assess specific website or service enquiries and/or for marketing communications and updates of interest;in each case, in accordance with this privacy policy.

## Keeping Data secure

14. We will use technical and organisational measures to safeguard your Data, for example:
  - a. access to your account is controlled by a password and a user name that is unique to you.
  - b. we store your Data on secure servers.

15. Where we process data provided to us by a third party that may include personally identifiable information in order to deliver a service as part of a contract, we ensure that the data is anonymised. If this is not immediately possible due to the nature of the work, the data is anonymised as soon as it is possible to do so.
16. We are certified to airtable.com Information Management Security system-compliant. This family of standards helps us manage your Data and keep it secure.

## Data retention

21. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

## Your rights

22. You have the following rights in relation to your Data:
  - a. **Right to access** - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
  - c. **Right to erase** - the right to request that we delete or remove your Data from our systems.
  - d. **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.
  - e. **Right to data portability** - the right to request that we move, copy or transfer your Data.
  - f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.
